### **UK PRICES MAINLAND**

Trade prices exclude VAT and carriage and may alter without prior notice. There will be a small order charge that includes carriage as follows:

For orders under £100 (ex VAT) minimum charge £15

For orders under £250 (ex VAT) minimum charge £10

For orders over £250 (ex VAT) carriage paid

### **OVERSEAS PRICES**

All orders are ex-works. Carriage will be charged at cost. Please specify preferred method of dispatch when placing your order. For prompt quotations please use our email or fax service.

### **DELIVERY**

Any losses or pilferages during transit must be reported in writing within three days from the delivery date. Damaged parcels must be signed for as damaged.

Please note we do not deliver to third party addresses.

### **OUR TERMS**

**If a credit account is agreed** then our credit terms are strictly 30 days from the date of invoice. By signing these terms and conditions you agree to any credit checks being carried out as required by ourselves. Any amounts outstanding after this may be levied with a 2% per month surcharge. Title to goods detailed in an invoice shall remain with Thatchreed Limited as full sole and absolute legal and equitable owner and shall not pass to you until we have received payment in full (in cash or cleared funds) for those goods and for any other goods that we have supplied to you.

### **RETURNS POLICY**
